### **PART I - Charitable Training Application Details**

---

To extend the reach of the National Resilience Resource Center and support especially promising entities, two training projects may be collaboratively undertaken annually as a charitable service. A competitive application process will identify one American and one international organizational recipient to receive free training each year.

---

**BACKGROUND INFORMATION:** Both American and international trainings for organizations are the basic NRRC *Introduction to Resilience and Health Realization: Finding Hope from the Inside Out*. Typically this training is spread over four days with as much as a month between sessions to allow participants to live and learn the principles. Depending on logistics and local needs, this schedule may be compressed and adjusted with winning entities during the final planning phase. [Outcomes](#) of this NRRC training content, process and plan has been independently evaluated to be highly successful based on two decades of NRRC training facilitation. **Winners will receive** the training service free of charge. This includes trainer efforts for planning, preparation, delivery and distance follow-up (phone and electronic) as needed, and certain training materials. At this time, all trainings will be conducted by NRRC Executive Director Kathy Marshall Emerson.

**Each winner is responsible** for travel costs for one trainer (flights, mileage, lodging, meals, local transportation), two books per participant, training facility with equipment, and interpreter if applicable. A host coordinator is needed to coordinate planning and recruitment, local event, and assist the NRRC trainer while onsite.

**APPLICATION PROCESS:** NRRC uses a two-step application process involving a *Letter of Intent to Apply*, and if approved to proceed, *Application for NRRC Charitable Training Service*.

**STEP 1: Letters of Intent** may be submitted prior to June 15 of each year. NRRC will respond within one month to indicate one of the following: **1.** Approval to submit a full application, **2.** Recommendations for improving the Letter of Intent and resubmitting to NRRC by June 15, or **3.** Disapproval for further consideration.

The Letter of Intent is limited to two typewritten pages on organizational letterhead dated and signed by the director with contact details and must include the following:

- One paragraph about the mission and purpose of your organization. (Public agencies, non-profits, educational institutions, or private businesses may apply.)
- Two paragraphs explaining how you became interested in this training, what similar training has already been received if any, why your organization needs this NRRC training, and what you hope to solve or accomplish.
- One paragraph about the leadership and structure of your organization and its' capacity to organize this training series, recruit participants and capacity to sustain impact over time.
- One paragraph explaining the organization's financial ability to accommodate the travel and other costs related to this training (excluding trainer fees).
- One paragraph indicating names and positions of the two or three main people who would spearhead the training event locally.
- A concluding statement clearly stating why your organization may be the best choice for receiving this NRRC national or international charitable service.

## **STEP 2: INVITED APPLICATION**

Entities that are approved in writing by NRRC to proceed to the formal application stage will be notified in writing. A brief *NRRC Application Form and Instructions* will be attached to that message. Applications are due by September 1 each year. All applications will be reviewed and winners announced on or before October 1. Services will be provided in a mutually beneficial timeframe within the next nine months.
